# Planning/Preparation

- \*(1) Strategically plan for the implementation of the Homeless Program
- \*(2) Develop, maintain and utilize a community resource file.
- \*(3) Review district program goals and objectives for consistency of purpose

### **Program Management**

- \*(4) Maintain individual files on each student, including entry/exit and program evaluations.
- \*(5) Maintain records and reports in auditable form
- \*(6) Manage Time effectively
- \*(7) Assist in maintaining security of records

### **Assessment Assistance**

- \*(8) Assist in evaluating each student prior to and upon entry
- \*(9) Monitor the progress of students placed
- \*(10) Assist in evaluating program effectiveness and suggest means of improvement

# **Service Delivery**

- \*(11) Ensure that children and youth in homeless situations are identified by school personnel and through coordination activities with other entities and agencies.
- \*(12) Help unaccompanied youth choose and enroll in a school, after considering the wishes of the youth, and provide the youth with a notice of their right to appeal an enrollment decision that is not their choice.
- \*(13) Prepare and maintain required reports and records as requested
- \*(14) Ensure that unaccompanied youth are immediately enrolled in school pending resolution of disputes that might arise over school enrollment or placement.
- \*(15) Inform parents or guardians of educational and related opportunities available to their children and provide them with meaningful opportunities to participate in the education of their children
- \*(16) Ensure that parents and guardians and unaccompanied youth are fully informed of all transportation services including the school of origin, and are assisted in accessing transportation services
- \*(17) Ensure that public notice of the educational rights of students in homeless situations is disseminated where children and youth receive services under the McKinney-Vento Act.
- \*(18) Carry out dispute resolution processes as expeditiously as possible in accordance with the enrollment disputes section of the McKinney-Vento Act after receiving notice of the dispute.
- \*(19) Assist students with obtaining immunizations or medical and immunization records
- \*(20) Assist the student or parents with the completion of free/reduced meals application.
- \*(21) Provide, as needed, access to special programs such as Special Education, Head Start, Title I, Gifted and Talented programs, Even Start, and Programs for English Language Learners.

#### **Collaboration**

- \*(22) Collaborate and coordinate with State Coordinators for the Education of Homeless Children and Youth, and community and school personnel responsible for the provision of education and related services to children and youth in homeless situations.
